(hereinafter referred to as 'THE **TRUSTEES**' which expression wherever the context so requires or admits shall mean and include their legal heirs, successors, executors, administrators and assigns of the **SECOND PART**).

WHEREAS the Settler is desirous of establishing a trust for Public Charitable Objects. And whereas the trustees have, at the request of the settler, agreed to act as the first trustees of these presents as testified by their being parties to and executing these presents.

AND WHEREAS it is necessary to declare the objects and terms of the Public Charitable Trust, being constituted under these presents.

Now this indenture witnesseth as follows

1. That in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of **Rs. 10,000/- (Rupees Ten Thousand only)** and hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. That the name of the trust shall be –

MERIT INSTITUTE OF EDUCATION

and its office shall, for the present be situated – VILL - GHOGARKUTHI , P.O – UTTAR GHOGARKUTHI , PS – TUFANGANJ , DIST – COOCHBEHAR , PIN CODE – 736159 , STATE- WEST BENGAL , INDIA . and / or at such other place or places as the trustees may decide from time to time. The organization will have jurisdiction over the area of West Bengal as well as all over India.

3. That the objects for which this trust is established are:

- I. To establish, promote, set up, maintain, or maintaining and or running Play School, KG School, CBSE School, ICSE School, School & Madrasa .

- II. To grant, pay or give scholarship, stipends prizes, rewards, allowances and other financial assistance or help in cash or kind to students .To run , establish library and reading rooms in needy communities.
- III. To celebrate the Birthday of the Great men of the Country, Red Letter Days, Festivals etc. in order to uplift the morality of the students.
- IV. To provide opportunity and resources for developing skills for employ ability and entrepreneurship, nurturing leadership qualities, imbibing professional ethics and societal commitment.
- V. To contribute to large developmental projects in government and public sector, jointly with industry partners, to demonstrate application of IT and get rich experience that can go back into education and research .
- VI. To start, run, maintain, take various State & Central Govt. Project Affiliation / Authorization / schemes for the development of the Community .
- VII. To start, run, maintain computer - IT literacy programme at various school for the development of Information Technology .
- VIII.To establish, maintain , conduct ,run all India basis Computer, Vocational , Skill Development & Industrial Training Education for Various Post Graduate Diploma, Advance Diploma, Diploma, Certificate Courses under the guidelines of Govt. of India .
- IX. To Encourage, maintain, run all over India basis computer, Vocational & Skill Development & Industrial Training programme by the objectives of National Task Force on IT & SD, Govt. of India (Action Plans Call- "Operation Knowledge ",1998 & 2003) .
- X. To promote, set-up, establish, develop, equip, maintain, providing All Over India basis Computer (software & hardware), Vocational, ITI, CAAD, Skill Development , Professional programme & other all allied courses training centre franchises distribution programme, Coordinator Distribution programme (State / Regional / Zonal) & affiliation programme .
- XI. To take Franchise, tie up, of different University (Indian) for running up Study Centre ,information Centre, Career Counseling Centre, National Coordinator, Regional Coordinator, Zonal coordinator.

- XII. To promote, set-up, establish, develop, equip, maintain, various State & Central Govt. Computer & Technical body & other Govt. Education projects affiliation.
- XIII. To establish, promote, set up, maintain, run Colleges , IT & ITI College, Medical College, Para Medical College , Pharmacy College, Physiotherapy College, Management College, Community College, Knowledge Hub .
- XIV. To start, run, maintain professional Coaching Centre / Training Institute, Education and Career Facilitator, Educational Consultancy, Student Counseling & Admission Guidance programme of University Regular & Distance Learning Programme.
- XV. To run, conduct all India basis online (e-system) Computer, Various Vocational & Skill Development, Post Graduate Diploma, Advance Diploma ,Diploma , Certificate Courses programme , online (e-system) Certification Programme .
- XVI. To Conduct all over India basis all category Job / Placement Cell , & Consultancy Unit as a service provider.
- XVII. To establish, promote, set up, maintain, run all over India basis Competitive Exam Training Institute to provide job-oriented teaching and training of competitive examinations .
- XVIII. To develop, run Management Academy , Soft Skill Academy & other need based & Industry , placement demand based Academy for the Development of Education by proper meeting resolution for activity & brand name .
- XIX. To Appropriate vocational skill training to SC & Minority youth & Tribal Affairs after proper demand assessment to facilitate employability and create options for non-farm livelihoods & Income generating programme.
- XX. To promote, set-up, establish, develop, equip, maintain, various State & Central Govt. Educational & Research projects accreditation & affiliation .
- XXI. To publish or publishing books, pamphlets, magazine ,news paper, audio & Video CD in India for the spread and advancement OF Education as non profit motive .
- XXII. To establish, run and maintain institutions in Sports including Football, Cricket, Boxing, Gymnastic, Long Tennis, Athletic,

Karate, other all sports training by proper meeting resolution for activity & brand name .

- XXIII.** To establish, run and maintain institutions for education and training in fine arts including Drama , Music, Dance, sculpture, Painting other theatrical arts and academic subjects by proper meeting resolution for activity & brand name .
- XXIV.** To work and fight against discrimination based on Cast, Creed, Colour, Gender, Religion, Faith, Race & Nationality.
- XXV** To propose a structured and pragmatic solution to address the lack of relevant skills amongst the current and potential workforce of India.
- XXVI** To celebrate annual day of the trust every year as cultural & social event.
- XXVII** To Promote the quality of higher education by investing in infrastructure and faculty, promoting academic reforms, improving governance and institutional restructuring towards the inclusion of the yet deprived communities.
- XXVIII** To raise funds through donation or subscription and other means with proper Norms & Legal Documents and invest money or incur expenditure in such manner as shall promote the attainment of aims and objectives of Trust .
- XXIX** To help youth to acquire knowledge skills to awaken social consciousness & responsibility .To conduct various camps i.e. trekking camps , snow skeing water sports , flying and eco development caps . To organize debates and declamation contest , speech .
- XXX.** To acquire or obtain on lease or in other manner, land, buildings, furniture, equipments, stores and other requirements for the purpose of the trust and the institutes etc. to be run by it and to sell, exchange, lease, mortgage or deal in any other manner with the movable and immovable properties of the trust and its institutes etc, run by it.
- XXXI** To establish , run, maintain all Over India basis collaboratively /Jointly Educational project with Proprietorship Concern, Firm, Company or any other Profitable organization. .

4. BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion, creed or sex.

5. PROPERTIES:

The Trust properties shall consist of-

- a) The amount Transferred by the SETTLER as mentioned above, towards the Corpus fund of the Trust.
- b) Any cash, kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over any property movable or immovable
- c) All additions and accretions to the Trust properties and the income there from
- d) All donations, gifts, legacies or grants, in cash or kind accepted by the Trustees upon Trust with proper Norms & Legal Documents .

The properties of the Trust shall be utilized for the objects set forth herein above and subject to the provisions and conditions herein mentioned.

6. NUMBER OF TRUSTEES, THEIR TERM AND POWER TO CO-OPT:

The Trust will be managed by a Board of Trustees consisting of not less than 3 trustees and not more than 15 trustees. The parties of the Second Part will be First Trustees and they shall automatically form the Board of Trustees

The term of office of First Trustees shall be for their respective lives. The Board of Trustees shall have the power to increase the total number of Trustees up to the maximum number stated above and fix their term as per provisions contained herein.

Any Trustee, including the Chairman (Managing Trustee) may retire from the Trusteeship hereof by giving two calendar months notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall If so fact to cease to be a Trustee of these presents.

Any vacancy caused by death of any one of the First Trustees, or any vacancy caused by the resignation of any of the Trustees, may be filled up by co-option by the Board of Trustees.

The Trustees who are not First Managing Trustee or First Trustees shall hold office for a period of one year from their date of appointment by the Trustees. At the end of this one year period, the Board of Trustees may reappoint them for subsequent term or appoint other persons as Trustees in such a manner that the total number of Trustees does not exceed the approved maximum number of Trustees.

The Chairman (Managing Trustee) shall have the power to remove a Trustee suffering from physical or mental disability or if he is accused of misfeasance of trust funds or property or misconduct, after satisfying himself on enquiry and such action of the Chairman (Managing Trustee) shall be final.

The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "Full Board", subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

7. TRUST ADMINISTRATION AND POWER TO THE BOARD:

A. The Board of Trustees shall have power to:

- I. To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.
- II. To open one or more bank accounts and operate the same or provide for operation of the said accounts by any two among them authorized on their behalf.
- III. To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961.
- IV. To buy, sell, mortgage, grant, lease, hire or otherwise alienate all or any of the properties of the Trust in its discretion for adequate consideration, so however any sale or alienation of immovable properties of the trust can be done only after obtaining the prior approval of the Commissioner of Income Tax.
- V. To execute power of attorney or powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the Trust for the purpose of all or some among the objects of the Trust.
- VI. To borrow money with or without security and to repay the same.
- VII. To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharges therefore.
- VIII. To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
- IX. To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, with proper Norms & Legal Documents by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- X. To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
- XI. The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
- XII. No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.

- XIII. The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income-tax Act, 1961.
- XIV. For the management and administration of the Trust, the existing Trustees shall hold the office for life. The management and administration of the trust will be guided by the Chairman (Managing Trustee.).
- XV. **All aims / objects / purpose of the trust herein stated above shall come into effect / force after necessary approval of the competent Govt. Authority in the cases where affiliation / permission / license / sanction is required.**

B. ROLES AND RESPONSIBILITIES AND POWERS

The Roles, Responsibilities and powers of all these officers is defined below. In addition to these, the Chairman (Managing Trustee)may grant additional roles, responsibilities and powers to any of the Trustees.

I. CHAIRMAN (MANAGING TRUSTEE) :

The Chairman (Managing Trustee) is authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government Institutions and other organizations, on behalf of the Board of Trustees. The Chairman (Managing Trustee)shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents. The Chairman (Managing Trustee) is empowered to remove any Trustee from the Trust and its offices, if He/ She finds that He /She activities are not congenial to the activities of the Trust (the Board has to prove that His/ Her activities are not congenial to the activities of the Trust and before removing Him / Her the Chairman (Managing Trustee) has to take an approval from the Board by a meeting after consulting with other Trustees) .

The Chairman (Managing Trustee)is responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

II. SECRETARY :

He /She shall Maintain minute books of all meetings . He /She shall Receive all applications for membership which shall be placed before the Governing Body. He /She shall Get the accounts of the Society audited by a Chartered Accountant. He /She shall Ensure compliance with statutory requirements.

III. TREASURER:

The Treasurer will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles

received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

8. MEETING OF THE BOARD OF TRUSTEES:

The Board of Trustees should meet at least once in every calendar quarter and may meet more often when required.

- I. The meeting of Board of Trustees shall be convened by the Chairman (Managing Trustee) and Chairman (Managing Trustee) shall preside over the meetings. In absence of Chairman, the Secretary can preside over the meeting. In the event the Chairman or Secretary are not able to attend the meeting already convened, any of the Trustees present in the meeting may elect one amongst themselves to be the Chairman of the meeting.
- II. One half of the Board of Trustees or a minimum of two trustees, whichever is higher, shall constitute the QUORUM for the Board of Trustee meetings.
- III. All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the Chairman (Managing Trustee) presiding over the meeting shall have a casting vote.
- IV. Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees and in consultation with the Chairman (Managing Trustee) for the furtherance and progress of the Trust.
- V. The meeting of the Board shall be conveyed after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.
- VI. The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of the Board, but they shall not be entitled vote in the meetings of the Trust .

9. BANK ACCOUNT:

The Chairman (Managing Trustee) and Secretary or Chairman (Managing Trustee) and Treasurer shall jointly Open & operate the Bank Accounts in the Name Of The Trust . In their absence, any of the Trustees and or any Member of the Trust may be authorized by the Board of Trustees, by a resolution, to operate the bank accounts. One or more Bank Accounts may be opened in any Bank and or Banks in the name of the Trust and provision should be there to open Bank accounts at Head Office , Corporate Office, Registered Office, State Office , Regional Office, Zonal Office , Branches/units of the Trust as may be deemed fit by the resolution of the Board of Trustees.

10. INVESTMENT OF TRUST FUNDS:

- I. The Board of Trustees shall have the power to invest the funds, assets and properties of the Trust at their discretion in accordance with the provisions of the Income Tax Act, 1961.
- II. The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.

11. ACCOUNTS AND AUDIT:

- I. The financial year of the Trust shall be from 1st April to 31st March of the following year, unless otherwise decided by the Board of Trustees.
- II. The Board of Trustees shall maintain true and correct accounts of the Trust.
- III. The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within three months of the close of the financial year.

12. AMENDMENTS:

- I. While this Trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the Trust, the Chairman (Managing Trustee) and First Trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution passed by at least three-fourths majority of the Board of Trustees present and voting. The amendments to the Trust deed, can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.
- II. If any alteration or amendment is necessary, the same shall be affected through supplementary deed/deeds with the previous approval of the Commissioner of Income Tax and these shall be read together with the main Trust deed.

13. MEMBERSHIP :

Any person over 18 years age irrespective of Castes, Creeds or Religion and who agrees in writing to abide by the Deed of Trust and the Rules & Regulation of the Trust to be framed from time to time for Membership of the Trust may be admitted as Member of the Trust.

14. INDEMNITY:

The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the Trust.

15. SETTLER AND THEIR RELATIVES:

Notwithstanding the powers vested with the Trustees under the proceeding clause, no part of the income of the Trust shall benefit directly or indirectly the trustees and no part of the income of the property of the Trust shall be used or applied directly or indirectly for the benefit of:

- (a) SETTLER, Managing Trustee ,Trustees or any person who makes a substantial contribution to the Trust or of any relative of the SETTLER, Managing Trustee ,Trustees or the person who makes a substantial contribution.
- (b) Any "related concern" in which any of the above persons has substantial interest.
- (c) For the purpose of this clause, the word "relative" and the phrases "related concern", "substantial interest" and "substantial contribution" shall have the meanings assigned to them in the Income Tax Act, 1961.

16. APPLICABILITY OF TRUST ACT:

The provisions of the Indian Trust Act 1882, Govt. Of India shall apply to all matters not specifically mentioned in these presents.

17. APPLICATION OF INCOME TAX ACT:

All clauses herein are intended to secure exemption from Income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is inconsistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

18. THIS TRUST IS DECLARED IRREVOCABLE:

19. DISSOLUTION:

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left if any, shall be disbursed to other Trusts or Associations having similar objectives after obtaining previous approval of Commissioner of Income-tax and in no event it shall be distributed in any manner, to any of the Board of Trustees or their relatives or related concerns.

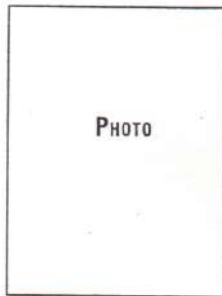

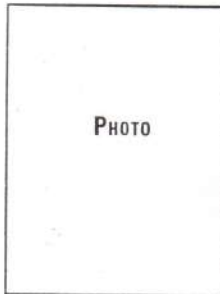


