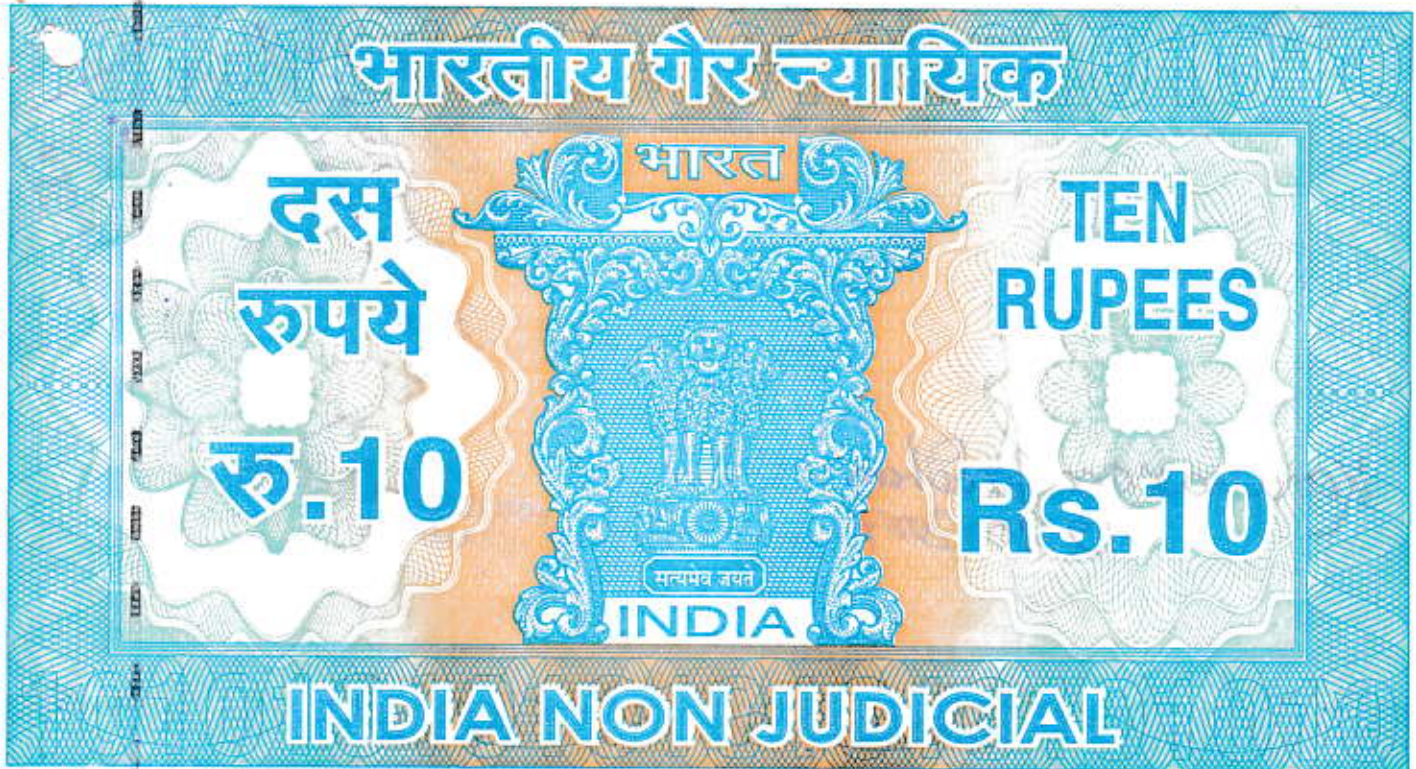

THIS DECLARATION OF TRUST is made on this 12th day of October 2007 by Dr. Karunakar Pradhan, S/O- Late Krushna Ch. Pradhan, aged bout 42 years residing at Plot No. 825, Mahaveer Nagar, Road No. 1, Jharpada, Bhubaneswar-6 [hereinafter referred to as " FOUNDER"] in favor of new Trust created and named below [hereinafter called the founder of the " TRUST"] which term shall wherever the context permits shall mean and include his / her heirs, successors, legal representatives, assignees, executors and administrators.

- 1) Whereas the Founder is desirous of establishing a Public Charitable Trust Whereas Bharatiya Vidya Niketan and setting on Trust a sum of Rs. 1000/- (One thousand Rupees only)
- 2) And whereas it is intended that the Trustees shall use the Trust funds for the purpose and objects of the Trust and hold the same on the Trusts hereinafter set out.
- 3) In this deed unless the context otherwise requires :
 - (a) The name of the Trust shall be Bharatiya Vidya Niketan Educational Trust and its office shall be at Plot No. 825, Mahaveer Nagar, Road-1, Jharpada, Bhubaneswar-6, Orissa; and at such other place or places mutually deemed desirable by all the Trustees from time to time to carryout and further the activities and objectives of the Trust.
 - (b) "TRUST PURPOSES" shall mean and include the "MISSION STATEMENT", "VISION DOCUMENT" AND " OBJECTIVES" described herein.
 - (c) "TRUST FOUNDS" shall mean the monies, securities and other assets, whether movable or immovable from time to time vested in the Trustees and whether the initially contributed by the Founder or subsequently obtained by way of gift, purchase or loan in any manner for the Trust purposes and any accruals and additions there to however arising.
 - (d) Words imputing singular shall include the plural and vice versa and words important the masculine gender shall include the feminine gender and vice versa.

8) **Objects of the Trust :**

- 1) To conduct and collaborate with the Governmental and Voluntary Agencies in "Mother and child Health Development Programmers" through health education, attentional care, immunization and family planning and to provide nutrition education to derive maximum benefits with the available and possible resources.
- 2) To establish, build, maintain, manage and administer institutions, +2 Science & Commerce college, residential school Nursery class to Plus Two (+2) under Bharatiya Vidya Niketan Trust. Science, Management Courses, Engineering, General Degree, B.Ed Training, C.T, N.T.T, Physical Training Courses and Diploma Courses including in specialized subjects and on another new area to be decided by the trust from time to time.
- 3) To establish institute to provide skilled, scientific, technical educational/training to enable younger generation to develop self-confidence and the skill to complete and succeed in the national and international field.
- 4) To affiliate the educational institution, schools and to allow such privileges to the institutions.
- 5) To control, manage, administer, transfer (or) appointment of teachers and other staff of the affiliated institutions.
- 6) To maintain and establish press and other establishments.
- 7) To spread general and technical education based on moral principle.
- 8) To establish maintain and manage a home or hostel for the boarding or lodging of the students, scholar, research students, working women, trainees or the other person, irrespective of caste, creed of faith, who may be engaged in the furtherance of the aims and objects of the trust.
